

***Bylaws of Central Calaveras Firefighter's Association
(As amended November 2013)***

The Bylaws of the CENTRAL CALAVERAS FIREFIGHTER'S ASSOCIATION (CCFA) shall be carried out in accordance with the Constitution of the CCFA.

Article 1. Membership and Attendance

Membership shall be governed by the Constitution of the CCFA.

Once a Regular Member has been elected, he or she shall be allowed to vote at all membership meetings.

Article 2. Reports

The Secretary shall submit the meeting minutes for the preceding meeting to the CCFA at each meeting. The meeting minutes from each meeting shall also be posted on centralcalaverasfirefightersassoc.org within ten days of the meeting.

The Treasurer shall submit a Treasurer's Report to the Members at each regular meeting. That report shall detail the cash position of the CCFA, including a current list of transactions for the time period since the previous regular meeting, accompanied by a copy of the latest bank statement. A summary of the Treasurer's Report shall also be posted on the CCFA website (www.centralcalaverasfirefightersassoc.org) as an attachment to the meeting minutes, as submitted by the Secretary, within ten days of the regular meeting.

The Treasurer shall provide upon request from any other officer, a detailed Financial Report of any/all accounts to the membership within 48 hours.

Article 3. Committees

All Committees of the CCFA shall be appointed by the President, and their renewable term of office shall be for the period of one year or less.

Article 4. Dues

The annual Membership Dues for Regular Members of the CCFA shall be \$1.00. This amount is subject to change as voted upon by the membership at any regular meeting; dues are payable at the first regular meeting of the calendar year or upon acceptance of a new Regular Member.

Should any Regular Member not pay his or her dues by the third regular meeting of the calendar year, his or her membership shall be considered inactive. If said Member wishes to reinstate his or her membership, the Member must at a regular meeting tender his or her dues and request consideration for membership, at which time the inactive Member will be reconsidered for active membership as provided in the CCFA Constitution.

Article 5. Meeting Time and Location

The CCFA will meet bi-monthly (July, September, November, January, March, May) at 6:00 PM on the first Wednesday of the month. Unless the President notifies the membership otherwise, the meetings shall be at Station 1 of the CCFRPD.

Article 6. Changes to Bylaws

Changes to the Bylaws are governed by Article 13 of the CCFA Constitution.

Article 7. Prizes at CCFA Events

No prize given by the CCFA at a CCFA event shall be paid for out of the funds of CCFA.

Amendment to Bylaws of Central Calaveras Firefighter's Association

Article 5 of the *Bylaws of Central Calaveras Firefighter's Association (As amended November 2013)* is hereby amended to read as follows:

Article 5. Meeting Time and Location

The regular meetings of the CCFA will be bi-monthly (July, September, November, January, March, May), at a date, time, and place (within the district of the Central Calaveras Fire and Rescue Protection District) as set by the President, with at least two days' advance written notice (see Article 11 of CCFA Constitution) provided to the members by the Secretary.
